



Warranty Terms For Broilmaster Grills Purchased Before November 30, 2001

Revised September 1, 2008

Empire Comfort Systems Inc. acquired the Broilmaster Grill Division in November 2001. The original manufacturer is no longer in business, and so is unable to cover their warranty claims.

Empire believes these warranties need to be honored even though we have no legal obligation to do so.

The original manufacturer's pro-rated warranty on stainless steel burners is based on the following schedule:

- Years 6-10, consumer pays 50 percent of the retail price in effect
- Years 11-15, consumer pays 75 percent of the retail price in effect

Effective September 1, 2008, a consumer with a valid proof of purchase (receipt) dated prior to November 30, 2001, may buy grids and castings according to this same schedule. This allows the consumer to pay subsidized prices on these items, even though the original funds set aside to cover these warranties have been exhausted.

All orders will be subject to the appropriate shipping charges.
